<u>1. EXECUTIVE SUMMARY</u>

1.1 INTRODUCTION

Jagannath Singh College Udahrbond is the only Degree College in the Udharbond L.A. Constituency. With a vision to fulfil the need for higher education in Udharbond area, Jagannath Singh College was established in April 1998. The college is named after the ex-minister of Assam, Late Jagannath Singh. The college is affiliated to Assam University, Silchar. Catering to the higher educational demand of the greater Udharbond area, the college began its journey with 34 students enrolled in B.A. (Pass) Course and 10 faculties in different subjects without its own land and buildings. The classes were started in 1999-2000 in J.R.D. Pubic High School. In 2003, the college shifted to its permanent building with construction of 3538 sq. feet ground floor. It was inaugurated by the then Vice Chancellor of Assam University, Dr. Subhash Chandra Saha.

Assam University Silchar granted permission of TDC Part I in 2000. The remaining two years of TDC course were gradually permitted by the university. The college also received necessary permission and approval in seven subjects, namely English, Bengali, Manipuri, Hindi, Political Science, Economics and History. The first batch students of Jagannath Singh College appeared in TDC final examinations in 2002 and the pass percentage in the first year was 45%.

In 2005, the college received concurrence of TDC Part I, Part II and Part III from Government of Assam. The College was provincialized by the Government of Assam in 2013. In the first phase of provincialization, the services of 13 staff including 5 teaching staff and 8 non-teaching staffs were provincialized with effect from 14th August 2013. The services of the remaining staff including the principal and 9 teaching staffs were provincialized by the Government of Assam with effect from 1st January 2021.

The College is spread across 5 bighas of land. It has seven departments namely Bengali, Economics, English, Hindi, History, Manipuri and Political Science,14 dedicated teachers and 9 Non-Teaching staff. In academic session 2021-2022, the college introduced B.A. in Bengali Hons., B.A. in Hindi Hons. and B.A. in Manipuri Hons.

- The college is located in a noise-free rural area that creates an ideal teaching-learning environment.
- The college is the only higher educational institution in the L.A.Constituency, Udharbond, Cachar, Assam which fulfils the higher educational thirst of most of the rural, socio-economically backward students.
- The college offers a positive interactive atmosphere for the students that make them approach the teaching and the non-teaching staff to resolve issues.
- Spontaneous, responsive mindset of the reading community in attaining education.
- Existence of a large and well-furnished library.

Institutional Weakness

- Student -teacher ratio of the college is not balanced.
- Communication with alumni is not satisfactory.
- Lack of adequate infrastructure facilities for teachers and students.
- The college lacks sufficient Govt./other funds.
- There is paucity of employed human resource for accomplishing teaching and non-teaching services.
- The college lacks hostel accommodation for students.
- Students have less awareness towards upcoming opportunities in terms of further studies and job opportunities.
- Lack of entrepreneurship promotional activities on the Campus.
- Inadequate language competency of the students due to their backward social background.
- Lack of philanthropic support to facilitate the students from weaker section.
- Absence of play-ground thwarted sporting culture on the Campus.
- Absence of research activities and research projects.
- No 12 B from UGC that offers financial support for faculty development.
- Absence of qualified and sanctioned librarian.

Institutional Opportunity

- The college may initiate collaborative programs in collaboration with other colleges in the field of teaching and learning.
- The college has the unique opportunity for contributing effectively towards the development of the region through research, development and extension activities.

- Existence of opportunity to introduce need-based new degree programmes and courses.
- Opportunity to enter into MOU's with industries and educational institutions to facilitate faculty members for exchange programmes and students to secure jobs.
- To orient the student community about various student-centric issues, topical issues etc. and to engage them in various activities through diverse committees/ cells of the college.
- Scope for introduction of Commerce and Science streams.
- Existence of a strong alumni base that may become the true ambassador of the college to lead it towards excellence.
- Existence of Placement Cell and Carrier Guidance Cell to orient the students for further course of studies and job opportunities.

Institutional Challenge

- To expand the institutional campus.
- The institution is located at a rural area.
- To reduce students drop-out trend.
- To minimise student drop-out ratio.
- Offer the students job-oriented courses.
- To increase human resources to cope with work-load.
- Poor schooling of the students and lack of basic knowledge on some subjects which creates problem in the progress of curriculum.
- To improve students' result in semester system course.
- To encourage research aptitude among faculty members.
- Extending physical infrastructure on the college campus.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Jagannath Singh College is permanently affiliated to Assam University, Silchar. The college is a general degree college in Arts stream with seven academic departments and 493 students on roll.

Being an Affiliated College, the institution delivers the curriculum designed by the Assam University. This College offers B.A. General Programme in seven subjects and B.A. Honours in three subjects, namely Bengali, Hindi and Manipuri. The curriculum is delivered by the college as per the rules and regulations of the affiliating university.

Present TDC-CBCS curriculum was introduced by the affiliating university w.e.f.the academic session 2018-19. Under CBCS, students can select their disciplines according to their choices. The courses in various subjects directly or indirectly deal with the issues and topics relating to gender equality, environment and sustainability, human values, ethics in professions etc.

In every academic session, the IQAC of college prepares academic calendar and class routine before the commencement of classes depending on the college prospectus and the university calendar. The teachers departmentally distribute the syllabus, prepare teaching plan for completion of the syllabus in time. A separate departmental routine based on the overall class routine is prepared by the Time Table Committee with

representation of HODs. Departmental activity plan is chalked out for the academic session. All these procedures are carried out prior to the commencement of classes in every semester. Hand written notes, Printed Study materials or PDF copies are circulated to the students as study materials. Unit Tests are conducted regularly following CBCS regulations of the affiliating university. The progress of each student in unit tests is recorded in the departmental unit test register. Remedial classes are organized for slow learners who are identified based on the results as well as classroom interaction. The college focuses on continuous and comprehensive evaluation of the students. Special class tests are also conducted by various department to assess the progress of the students. End semester examinations are conducted as per the norms of the affiliating University.

Teaching-learning and Evaluation

Jagannath Singh College admits students from different socio-economic background to the programmes offered by the college. The admission process is online. The college started admissionin online mode in 2019-2020 Session. Students become familiar with the Programmes and Course details of the college thorough college prospectus at the time of admission.

The college has 14 teachers altogether. Out of the14 teachers of the college, 13 teachers are Ph.D degree holders. The institution adopts student centric and ICT based learning methods to develop the students according to the needs of modern education. Extempore speech, seminar, group discussion, etc., are organized to develop and critical thinking problem solving ability among the students which in turn develop personality and leadership quality among the students and ensure their participation in field study, excursions and various co-curricular and extra-curricular activities organized by the College.

The learning level of the students is assessed through Continuous Comprehensive Assessment (CCA) as per CBCS Regulation, 2018 of the affiliating university, interactive classes, term end examination, class tests, unit tests, group discussions, and students' seminar. The performance of the students in the examinations is considered as a measure of the attainment of programme specific outcomes and course outcomes.

Examination related grievances of the students, if any is resolved quickly.

Special classes are taken for slow learners. Study materials are provided to the students. Advanced learners are motivated to excel in career and guided to appear in various competitive examinations. Course related information and study material are also provided to the students through departmental WhatsApp Group when required.

Research, Innovations and Extension

Motivation plays an important role in innovation. Students' seminar, workshops, interactions, guest lectures, and awareness programmes have been conducted by various departments, Cells and Committees from time to time. The college has taken all these initiatives to enrich the knowledge of the students and motivate them to acquire different life skills through the knowledge shared by the resource person.

To impart education through experience, various departments organize field trips and educational tour to different places.

Faculty members conduct research and publish papers in journals. During the last five years, a few faculty members published papers in UGC Care listed journals and chapters in edited books.

The central library of the college provides facilities for knowledge gathering and research support through reference books, digital library etc. The students are motivated to access the books from the library and acquire the knowledge.

Jagannath Singh College promotes participation of students and teachers in extension activities. The extension activities are generally carried out through NSS Unit and Cell for Extension Activity of the college.

NSS Unit of the college has carried out various extension activities through participation of its volunteers in activities concerning important social issues and sensitized the students on such issues. Participation in such activities enabled them to learn how to serve the society. Students and teachers donated blood in Blood Donation Camps organized in the College. It has received Gold Medal and Silver Medal from Sambandh Health Foundation and Assam Cancer Care Foundation, A Govt. of Assam and Tata Trust Initiative in the year 2018-19 for leadership in Tobacco Control.

The College maintains its social responsibility and commitment through holding extension activities in the neighbourhood community to sensitize students as well as community about social issues. The college regularly encourages involvement of students and teachers in society-friendly extension activities. Awareness rally was organized in Udharbond Dayapur Part II to sensitize common people about Azadi Ka Amrit Mahotsav. Awareness programme was also organized in Durganagar Village to aware common people about COVID-19. Extension programmes have not only raised the sense of social responsibility, team spirit, leadership qualities, humility, compassion and ethical values among the students but also made the society vigilant.

Infrastructure and Learning Resources

The college focuses on providing good physical and support facilities to create a learning environment of the students. It is a newly provincialized college and hence it has not yet developed state of the art infrastructure due to shortage of financial resources. However, as of now, the College provide the following facilities:

1. Classrooms: There are 8 classrooms with facilities like fans, lights, desks, benches, chairs, tables, blackboards etc.

2. Library: Library plays an important role in teaching-learning process. The central library of the college has an area of 204 sq. m. It has 2473 reference books, 2664 text books, 57 journals and 10 magazines. There is separate reading room for teachers and students. As part of the ICT updation, it has been automated with SOUL 3.0. One lab with 8 computers has been established to promote ICT based learning.

3. Campus Wi-Fi: The College provides free Wi-Fi facility for students and all the staff members.

4. **CCTV surveillance**: The college campus is under the 24 hours CCTV surveillance which is helpful in maintaining internal security and safety.

5. Separate Administrative Building: IQAC/Examination Room: The College has separate Administrative building with computer and Broadband connectivity. There is separate room for IQAC within the Administrative Building. The IQAC room has one computer with internet facilities.

The college provides sports facilities to the students for both indoor and some outdoor games. The facilities for indoor games are chess and carom board. The facilities for outdoor games are cricket, football, volleyball, kabaddi and badminton.

Cultural activities are held in large halls. Cultural events such as observation of birth anniversaries of great personalities, observation of Saraswati Puja, celebration of Milad Mehfil, music, dance etc. are conducted by cultural committee. The students actively participate in the organization of cultural events. These events inculcate the cultural and traditional values among the students. The students enthusiastically participate in the cultural events.

Jagannath Singh College has well established procedures and policies for maintaining and utilizing physical, academic and support facilities.

Student Support and Progression

Jagannath Singh College is located in remote area of India which is industrially backward. Hence, the College faces limited job opportunities for students. However, the Placement Cell and Career Counselling Cell of the college provide guidance and counselling to the students with regard to higher studies and placement.

The college has Admission Committee, Anti-ragging Cell, Internal Complaints Committee, Discipline Committee, Examination Cell and Grievance Redress Cell. These cells and committees look after their respective cases.

Most of the students accommodated by the college come from the vulnerable section of society. They are the beneficiaries of Fee Waiver Scheme of Assam Government. The College also provides financial support to needy students.

Jagannath Singh College has constituted Alumni Association to establish a connection between the former students and the college. The alumni have pivotal role in the advancement of an institute.

The college has produced many graduates over the years. Many of them are established now in different spheres of social life. The institute maintains a good connection with the alumni. The alumni are contributing to the development of the institute through donation and support services. The Alumni Association of the college is yet to be registered.

Governance, Leadership and Management

The Governing Body performs the supervisory and advisory roles to enhance the growth of the institution. The principal of the college always leads from the front in formulating the necessary policies and involving the teachers and the staff in achieving the vision and mission of the college.

For proper execution of academic and administrative functions, the college adopts the principle of decentralization and participative management. Decisions are made following down up approach. Teachers are assigned academic and administrative responsibilities. Different cells and committees have been formed like the Anti-Ragging Cell, IQAC, Examination Cell, Grievance Redressal Cell, Discipline Committee, NSS Cell, and Cultural Cell and so on for smooth functioning of the institution to achieve the stated vision and mission.

Whatever Grants and aids have been received are utilized following standard norms and guidelines. Internal and external financial audits are regularly carried out in the College.

The performance of the teachers is assessed as per the Performance Based Appraisal System (PBAS). There are ample avenues for the teaching and non-teaching staff for career advancement.

Leave and other benefits are provided by the college to the teaching and non-teaching staff.

The institution maintains a transparent and accountable financial management system. The account section of the college maintains day to day records of financial matters. Stock registers are maintained and kept up to date.

The financial aspects of the college are audited by a hired chartered accountancy firm after completion of every financial year.

The IQAC has played an important role in institutionalizing quality and higher standards. It acts as an advisory Body to the GB for academic and infrastructural improvement of the college. Without any fund, the IQAC of the college has contributed towards holding numerous academic and administrative activities. It has also contributed in organising awareness programmes, seminars, webinar, workshop etc. in the institution.

Institutional Values and Best Practices

The college promotes gender equality and sensitization by conducting co-curricular activities like workshops, seminars, special lectures, counselling, observation of International Women's Day etc. The Women's Cell in association with IQAC has conducted Gender Audit to assess the participation of women in decision making and overall work dispensation along with the facilities available for their safety and security.

The institution accommodates students with diverse socio-cultural, communal and linguistic background. The institution promotes tolerance and harmony towards cultural, linguistic, communal, socio-economic and other diversities by making them participate in different socio-cultural activities organized by the institute.

The institution has taken various initiatives to observe days of great personalities, National festivals and other such activities to provide an inclusive environment. These activities create an inclusive environment by bringing students and teachers with diverse background on single platform. These activities also help in developing tolerance and harmony towards cultural, linguistic, communal, socio-economic and other diversities.

Constitutional responsibilities, values and rights are part of the curriculum. The institution observes the two national festivals-Republic Day and Independence Day every year. Constitution Day and National Voter's Day are also observed which instil a sense of nationalism and good citizenship among the students.

The institution has taken initiatives for making the campus eco-friendly thorough planting trees on a regular basis, avoiding plastic usage to make it plastic free campus and disposal of wastes. Measures have been taken for rain water harvesting. Green Audit and Energy Audit have been conducted in 2021-2022 session.

The institution organizes certain activities like awarding the Best Graduate and holding Blood Donation Camp and observation of days of national and international importance on a regular basis.

1.1 Curricular Planning and Implementation

1.1.1

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

The College is affiliated to Assam University, Silchar. Curriculum is planned by the affiliating university and follows the curriculum prepared by the university. However, the college provides support to Assam University in curriculum planning through representation of teachers in BUGS as members.

The admissions of TDC First semester students are generally completed before the month of August as far as possible. Admission in Third and Fifth semesters are also completed before the month of August.

The college prepares Academic Calendar for each session in accordance with the Calendar provided by the university. The academic calendars are prepared on the basis of Academic Calendar circulated by the affiliating university with the tentative schedules of entire session. The Prospectus prepared by the college mentions the Semester specific courses and also the evaluation procedure.

Prior to the beginning of the semester, class wise Time Table is drafted and finalized by the Time Table Committee. The overall Time Table is handed over to the Principal through Coordinator, Time Table Committee for having it displayed on the Notice Board for information of the concerned students.

Well ahead of the commencement of classes of a semester, the Heads of the Departments convene meeting in their respective department to allocate the periods of various classes based on the overall Time Table and distribute courses. The contents of the syllabus with respect to Paper, Units and Topics to be delivered are unanimously distributed in the meeting after careful consideration of subject specialization, interest and experience of the teachers. The faculty members prepare teaching plan for timely completion of syllabus.

Printed or hand written study materials are generally provided after the completion of a Unit/Topic.

Besides classroom teaching along with traditional chalk and talk method, students' seminars, workshops, special lectures, group discussions, Tutorials, remedial teaching for poor performers in examinations ,educational tours and field trips are conducted in a well planned manner from time to time in the delivery process.

Record of the regular attendance and progress of the students in CCA is maintained and preserved by the respective teachers. In maintenance of CCA, according to the Regulation of TDC under CBCS of the affiliating University; there is provision for awarding marks according to the percentage of attendance in the courses except AECC and SEC.

Continuous Internal Assessment:

Continuous Comprehensive assessment and academic progress of students through Internal Tests is followed. Internal Assessments are conducted regularly. The institution conducts two compulsory Unit tests in a semester following the CBCS Regulations of the affiliating university and submits the marks obtained by each student in both the tests to the university along with percentage of attendance for each student within a stipulated date as set by the university. There is provision for debarring absentees or students who cannot secure 12 marks including minimum 6 marks for attendance in Continuous Comprehensive Assessment (CCA) from appearing at the end semester examinations as incorporated in the regulation under CBCS. To check unfair means in the examination and for all matters of examinations, the institution strictly follows and applies all Rules and Regulations of the affiliating university.

1.3 Curriculum Enrichment

Response:

The College is affiliated to Assam University, Silchar and adheres to the curriculum prepared by the university. The issues and topics relating to gender equity, environment and sustainability, human values and professional ethics have always been included directly or indirectly in the various courses of different subjects.

Various Courses offered by the college deal with issues Gender, Environment and Sustainability, Human Values and Professional Ethics etc. which have high relevance in the society. For example, there are topics in subjects like Bengali, Economics, English and Hindi which deal with gender issues. In Political Science, there is a Skill Enhancement Course entitled Democratic Awareness and Legal Literacy in fifth semester which deals with topics relating to dowry, sexual harassment and violence against women. Likewise, Skill Enhancement Course entitled Small Business and Entrepreneurship Development in economics in fifth semester covers topic on women empowerment.

Premchand's Nirmola is included in Hindi Discipline Specific Core Course entitled Hindi Gadya Sahitya for 4th semester students. This novel of Premchand basically deals with human values.

'Environmental Studies' as a compulsory subject under AECC for all UG students in second semester deals with different aspects of environment, natural resources, environmental degradation,

environmental pollution and human health, climate change, ozone layer depletion, environmental movements and other environmental issues and sustainable development. Further, Economic Development and Policy in India-I, a Discipline Specific Elective Course in economics for fifth semester students covers topics on sustainability.

Apart from the curriculum, the college regularly takes steps to integrate the cross-cutting issues mentioned above to the curriculum by organizing events, quiz competition and special lectures having bearing on gender equity, environment and sustainability, Human Values and Professional Ethics.

The college also emphasizes on value based education. Communal Harmony, Dignity of Labour and concern for the differently abled are the Human Values that the institution tries to instill in the minds of the students.

There are specific committees and cells like Beautification Cell, Women's Cell etc. which make efforts to sensitize the students on issues like Gender equality, Human rights, Environment etc.

The institution also promotes the core values of gender equity, environment, sustainable development, human values, professional ethics etc., through in many of its co-curricular and extra-curricular activities. All get equal opportunities to have their representation in various activities of the irrespective of gender.

Jagannath Singh College focuses on student centric methods in regular teaching-learning process to enable the students to be more self-reliant, self-motivated and makes learning as interesting and effective.

Learning through Experience: Excursions and field visits are organized from time to time to encourage students to get an on-site idea of concepts they study through syllabus. Going on such tours develops their critical thinking skills. Such tours strengthen the relationship between teachers and students and also help in enhancing social and interactive skills of the students.

Participative Learning: The institute focuses on the holistic development of the learners. All the learners from different sections of the society are given equal opportunity and special attention and care is given to each and every learner for his/her overall development.

Regular classroom teaching-learning is participatory and interactive. Learning is made student-centric by conducting student seminar, field visits, educational tour, interactive sessions, organizing group discussions, brain storming sessions etc. Students are motivated to write articles, poems, essays and reports for the college wall magazine in different subjects. Language classes play an active role in enhancing the communication skills of the students.

Various co-curricular activities like inter-college and departmental quiz, debate, extempore speech, sports and cultural events are conducted to ensure participations of learners in such activities. Learning is also made participatory by organizing workshops, training and seminars which help the students to improve their knowledge of their concerned subject and these give an opportunity to introduce themselves to new concepts. 2.5 Evaluation Process and Reforms

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

Continuous Comprehensive Assessment (CCA): As per the TDC CBCS Regulation 2018 of the Affiliating University, internal assessment is a part and parcel of Continuous Comprehensive Assessment process in TDC Programmes which is comprised of Internal Tests and Attendance in Classes.

Conduction of Internal Examination:

The examination committee is entrusted with the responsibility of the preparation of examination Time Table and conducting the internal examination. The concerned departments are given responsibility to set question papers which are submitted to the examination committee formed by the Principal. Invigilation Duty Schedules involving all the teachers of the College are prepared by the examination Committee ahead of commencement of internal examination.

Evaluation of Answer Scripts of Internal Test and Uploading of marks in the Website of Affiliating University: After conduction of internal tests, the name of paper evaluator from the concerned department is recommended by the Head of each Department to evaluate answer scripts of papers. After evaluation of answer scripts, the departments submit the marks foil to the examination cell of the college. These marks as well as attendance percentages are uploaded by the examination cell with support from office of the college in the web portal of the affiliating university within stipulated time.

Procedures maintained for making Internal Assessment transparent: The evaluated answer scripts are shown to the students by the concerned teacher after completion of evaluation process so that the students can know their performance in the test. The teachers explain their mistakes and doubts if any with due care. The marks foils of internal assessment are displayed on the Notice Board for information of the students after evaluation process is completed. It makes easy for students to report their

grievances, if any.

The grievance redressal system of the college is time bound and efficient.

Internal examination is conducted in compliance with TDC-CBCS Regulation of the affiliating university. All the rules and regulations of examinations circulated by the affiliating university are strictly followed and no unfair means is allowed in the examinations.

The evaluated answer scripts are shown to the students by the concerned teachers in their class room. Any discrepancy identified and reported by the student is resolved there. The marks foils are uploaded on the Notice Board so that the students can view their marks which ensure transparency. Students can report their grievances, if any. Internal examination-related grievances of the students are generally redressed by the concerned teachers at the department level.

Grievances relating to post-uploading discrepancies of Marks are resolved with efforts made by concerned Departmental Heads, Convener of Examination Committee and concerned Staff of Office of the college in consultation with Examination Branch of the University within stipulated time.

The college office and examination committee always help the students in all possible ways. The Principal of the college always remains vigilant Tto ensure that the students do not have to face any problem due to technical anomalies.

The affiliating University allows reevaluation of answer scripts within stipulated time from the date of declaration of results.

3.4 Extension Activities

3.4.1

Outcomes of Extension activities in the neighborhood community in terms of impact and sensitizing the students to social issues for their holistic development during the last five years.

Response:

The College maintains its social responsibility and commitment through extension activities in the neighbourhood community and sensitize the students and the community about social issues. The college regularly encourages involvement of students and teachers in society-friendly extension activities.

The college was recruited as COVID-19 Quarantine Centre with 38 beds and 91 numbers of COVID-19 suspected persons who were quarantined during the pandemic.

Infrastructure and other facilities for teaching- learning:

The details of the available infrastructural and physical facilities in the college are as follows:

- 1. **Classrooms**: Classroom is the backbone of any institute's infrastructure. The College has 8 classrooms. Out of the 8 classrooms, 3 are large, 2 are medium and 3 are small rooms. There is good ventilation in all the classrooms along with facilities like fans, lights, desks, benches, chairs, tables, blackboards etc.
- 2. **Library**: The central library of the college has an area of 204 sq. m. It has 2473 reference books, 2664 text books, 57 journals, 10 magazines. There is separate reading room for teachers and students.
- 3. **Computer Lab**: The College has one computer laboratory with internet facilities to ensure effective teaching-learning. The computer laboratory with 8 computers is open to all students and teachers of the college.
- 4. Campus Wi-Fi: The college provides free Wi-Fi facility for students and all the staff members.
- 5. **CCTV surveillance**: The college campus is under the 24 hours CCTV surveillance installed in various locations within the campus which is helpful in maintaining internal security.

7.**Separate IQAC Room:** The college has separate room for IQAC within the Administrative Building. The IQAC room has one computer with internet facilities.

ICT-enabled facilities:

Digital Library: The Central Library is automated with SOUL 3.0 software.

Automated office: The office of the college is automated.

Facilities for cultural and sports activities yoga centre, games (indoor and outdoor), gymnasium, auditorium etc.,

For the holistic development of the students, sports and cultural activities are organized by sports and cultural committees of the college respectively.

Sports facilities: The College provides sports facilities to the students for both indoor and outdoor games. The facilities for indoor games are chess and carom board. The facilities for some outdoor games are cricket, football, volleyball, kabaddi and badminton. Various sports events like Long Races, Long Jump, High jump, Shot put, Javelin throw, Kabaddi, Tug-of-war, Cricket, Badminton, Chess, Carom, Musical chair, etc. are held in sports week.

The college does not have a well developed playground of its own. The open space inside the campus of the college is used for outdoor games like Races, Long Jump, High jump,etc. The College team participates in the inter-college sports at the university and district level like football and cricket when such inter-college sports are organized.

Cultural Activities: Cultural events such as observation of birth anniversaries of great personalities, observation of Saraswati Puja, celebration of Milad Mehfil, music, dance etc. are conducted by cultural committee. Saraswati Puja is celebrated every year in the college. These events inculcate the cultural and traditional values among the students. The students enthusiastically participate in the cultural events.

Gymnasium: The College does not provide any facility for gymnasium.

Yoga: The College does not have separate centre for Yoga. However, the college observes International Yoga Day to encourage the students for healthy life.

4.2 Library as a Learning Resource

4.2.1

Library is automated with digital facilities using Integrated Library Management System (ILMS), adequate subscriptions to e-resources and journals are made. The library is optimally used by the faculty and students

Response:

The present age is the age of information and is also called computer age or digital age. The use of ICT in library services is increasing day by day due to the advancement of Information and Communication Technology (ICT). ICT makes functioning of library easier, faster and effective.

The library is the store house of knowledge. It is helpful for the students and the staff to acquire more knowledge about any particular subject. Library automation is the use of computer in library works to keep record of all the books which are issued, returned and added in the library. It is simply the use of computer and networking technologies in the library. An automated library reduces the workload of the staff and raises the efficiency of the library. It encompasses the process of replacing the traditional functions of libraries with computer and software.

Keeping in mind the importance of ICT facilities in library and advantages of library automation, Jagannath Singh College, Udharbond started the process for library automation in March 2022 despite having paucity of funds. The college believes in the proverb "where there is a will, there is a way". The college approached Shri Kaushik Rai, the M.L.A. of 13 No. Lakhipur Constituency of Assam for financial support to digitise the library of the college. Accordingly, Shri Kaushik Rai came forward and donated necessary fund to the college for the purpose of digital library from his own fund. As per the wish of the donor, the digital library of the college is named after Late Beni Madhab Das, the popular political leader of Udharbond area. The central library of Jagannath Singh College has been automated through Integrated Library Management System (ILMS) using the Software for University Libraries (SOUL). SOUL is integrated library management software designed and developed by the INFLIBNET Centre. It is user-friendly software developed to work under client-server environment. The software is compliant to international standards for bibliographic formats, networking and circulation protocols. SOUL 3.0 Version has been installed in the college library.

The central library of Jagannath Singh College,Udharbond began automation of its library with Cataloguing Module of SOUL software for the purpose of creating book database. However, the college faces shortage of library staffs. The catalogue of books is supposed to be accessed through OPAC(Online Public Access Catalogue) module by the teachers and the students of the college. Uses of other modules of SOUL like acquisition, circulation and serials control will be made available in the days to come.

The college has three tier governance structure:

The Governing Body;

The Principal;

The Governing Body is the top most tier of governance. The Governing Body exercises the supervisory and advisory roles to enhance the growth of the institution. The apex body led by the dedicated and eminent educationists is putting continuous efforts in infrastructural and ICT upgradations in accordance with the above mentioned vision and mission of the college.

The next tier of governance of the college is the principal who is the head of the institution and ex-officio secretary of the Governing Body. Being the head of the institution, the principal looks after the day to day administrative and academic affairs of the college and executes the policies adopted by the

Governing Body, the Govt. and other statutory bodies like the University and UGC.

The NEP 2020 will be implemented by the affiliating university from the session 2023-2024. The college has taken initiatives to build necessary infrastructure for the implementation of NEP 2020.

The teachers, the convenors of different cells and committees and the IQAC are at the grass root level of governance. They co-operate with the principal for smooth execution of the academic and administrative affairs of the college.

Upon considering the above vision and mission, the governance prepares short term and long-term perspective plans for the advancement of the institution. The principal of the college always leads from the front in formulating the necessary policies and involving the teachers and the staff in fulfilling the stated vision and mission.

In the execution of academic and administrative operations, the college adopts the principle of decentralization and participative management. Decisions are made following down up approach. Teachers are assigned academic and administrative responsibilities. Different cells and committees have been constituted like the Anti-Ragging Cell, IQAC, Examination Cell, Grievance Redressal Cell, Discipline Committee, NSS Cell, Cultural Cell and so on for smooth functioning of the institution to achieve the stated vision and mission.

Besides smooth implementation of academic activities, the teachers play proactive roles in IQAC for conducting various co-curricular activities, extension activities, etc.

6.2 Strategy Development and Deployment

6.2.1

The institutional perspective plan is effectively deployed and functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment, service rules, and procedures, etc

Response:

Administrative Structure:

The Governing Body: It is the apex body of the college, The GB has been constituted as per Rule 3 of the Assam Provincialised Colleges and Assam Non-Govt. College Management Rules, 2001. The Governing Body is responsible for the proper financial management, management of academic affairs and infrastructure development of the college. It is the review authority of teachers for their performance in

classes, examination duties, attendance and promotion. The major decisions taken in the staff meeting chaired by the principal are placed before the Governing Body for approval.

The Principal: The Principal is the ex-officio member secretary of the Governing Body .The execution of the polices formulated by the Governing Body, the Govt. and other authorities like the affiliating university and the UGC rests on the principal. The teaching and non-teaching staff of the college provide support to the principal in executing the rules and regulations and the actions plans chalked out by the Governing Body.

Academic Incharge: The Governing Body of the college has appointed an academic in-charge from the senior most faculties to look after the day to day academic affairs of the college. The academic in-charge is responsible for smooth holding of classes as per time-table.

The HODs: Jagannath Singh College was provincialized by the govt. of Assam in 2013. Presently, the college does not have any sanctioned Associate Professor Post. So, senior most faculty of each department acts as the HOD. The head is responsible for academic affairs of the department. The departmental colleague cooperates with the head for the smooth execution of the academic activities of the department.

IQAC: The IQAC of the college was established in 2015 and it has been reconstituted as per NAAC guidelines in 2022. The IQAC plays an important role in maintaining quality and higher standards. It acts as an advisory body to the GB for academic and infrastructural improvement of the college. It sets the benchmarks for quality enhancement. It conducts the Academic and Administrative Audit of the college.

Library: The college has an automated library with the librarian (non-sanctioned), one library assistant and one library bearer.

Appointment of the teaching and non-teaching staffs: The services of the staffs of the college were provincialized by the Govt. of Assam. The Principal and teachers were initially appointed by the GB as per UGC norms and regularized by the govt. of Assam after fulfilling the eligibility criteria for provincialization. The non-teaching staff were initially appointed by the Governing Body as per the norms of the state govt. and then regularized by the Govt. of Assam.

Service Rules: The college strictly adheres to the service rules for the employees set by the Govt. of Assam. The college follows the Assam Service (Discipline and Appeal) Rules, 1964 and Assam College Employees (Provincialisation)Rules 2010 relating to the service related matters of the employees.

The performance of the teachers is assessed as per the Performance Based Appraisal System (PBAS). There are ample avenues of the teaching and non-teaching staff for career advancement.

Promotion of the teachers under UGC Career Advancement Scheme (CAS) is based on the annual API score in the prescribed PBAS Proforma. The PBAS is based on the following aspects as per UGC Regulations 2010:

- (1) Teaching, Learning and Evaluation Related Activities;
- (2) Co-curricular, Extension and Professional Development Related Activities and
- (3) Research Publication and Academic Contributions.

The performance of teachers in these three areas of assessment is verified and approved by the principal on satisfactory API scores. After verification of self-assessed API scores, Departmental Promotion

Committee (DPC) with members from the Affiliating University recommends the candidature of teachers for promotion. The college maintains all the procedures of promotion after DPC.

Promotion related files of four faculty members of the college from Assistant Professor Stage I to Assistant Professor (senior scale) has been forwarded by the office of the principal to the competent authority for necessary recommendation after completing all procedures in 2022.

Promotion of non-teaching staff is time bound. The performance of non-teaching staff is assessed for promotion through Annual Confidential Reports. Promotion is granted on satisfactory performance.

7.1.1

Institution has initiated the Gender Audit and measures for the promotion of gender equity during the last five years.

Response:

The institution has conducted the gender audit in 2021-2022 session to find out the gender equality in the college thorough structured questionnaire.

Measures taken for the promotion of gender equity during the last five years:

1. Safety and Security:

i. CCTV Surveillance: CCTV cameras are in place. It is helpful in preventing anti-social elements. A sense of security to the women is provided by the 24 hour CCTV surveillance. Wearing identity cards by the students are mandatory within the campus to ensure their identity.

ii. Different committees in the college campus: For safety and security, the college has Internal Complaints Committee (Committee Against Sexual Harassment), Anti-Ragging Cell, Student Grievance Redressal Cell and Discipline Committee. These committees monitor safety and security of the students. It also keeps a watchful eye on the activities of all the employees and the students within the campus.

2. Appointment of Female staff:

The college appointed staff on the basis of merit wiyhout any gender discrimination. At present, 50% of the faculty members are female in the college. The female faculty members have been assigned the responsibilities of HODs and Convenors of different cells and committees. There is also female non-teaching staff in the college.

3. Active participation by female teachers and students:

Female teachers and students also actively take part in the events organized by different departments and committees of the college. Girl students accompanied by female teachers are permitted to go on excursion, field trips, etc.

Gender equality and sensitization have been introduced in the curriculum also. For example, in the old semester system which was effective till 2017-2018 before the introduction of TDC CBCS, Foundation Course in Environmental Studies, a compulsory paper dealt with gender equity and sensitization. A Chapter in the FCES was devoted to such issues under the heading "Role of Women and Environmental Sustenance".

The college promotes gender equality and sensitization by conducting co-curricular activities like workshops, seminars, special lectures, counselling, observation of International Women's Day etc.

The Women's Cell of the college observed International Women's Day, 2022

The Self-Empowerment Committee of the college organized one day workshop on beautification course in association with IQAC for career advancement of the female students.

A programme on gender sensitization was organized by the Internal Complaints Committee (Committee Against Sexual Harassment) on 14th December, 2021.

1. Title of the Practice: - "Best Graduate Award" by the institute.

2. Objectives of the Practice: -The objective is to provide formal recognition of students in their respective field of study. They are motivated for further progress and prepare themselves for various

competitive examinations along with traditional UG curriculum.

3. The Context: - Students of the College securing highest marks in their stream are awarded every year with "Best Graduate Award". At UG level, students are enrolled from varied background. Slow learners are identified and are provided with remedial teaching to bring them in the mainstream.

4. The Practice: - As a part of the practice, "Best Graduate Award" is given to the best performer in Arts stream on the basis of the final results as per the CGPA norms of the affiliating university.

The award is given formally by the Principal in an Annual Award Ceremony. The tradition of conferring "Best Graduate Award" upon students for academic performance has been in practice since 2017 and it is given in the memory of late Dilip Deb Mazumder from 2019. The award is funded by Dr. Munni Deb Mazumder in memory of her late father Dilip Deb Mazumder.

The practice of "Best Graduate Award" has enhanced the healthy competitions among the students in the field of -

- 1. Academic studies as per UG Curriculum.
- 2. As an effective strategy for teaching learning process.
- 3. Motivate students to take part in various competitive examinations.

6. Problem encountered and Resource required: Traditional University curriculum especially in the faculty of Arts is not sufficient for placement and job opportunities. Students from rural area including tea garden area are extremely poor and lag behind in use of technology as well. Most of the students belong to rural background of poor families. Feedback collected revealed that percentage of students getting placement is comparatively low. The area is basically agriculture based and industrially backward and hence scope for placement is very less. So, College need various skill development-job oriented programme to minimize the issue of unemployment.

Practice No. 2

1. Title of the Practice: - Voluntary Blood Donation Camp organized at the College by NSS Unit.

2. Objectives of the Practice: - To aware the students as well as the local people regarding necessity of Blood donation.

3. The Context: - Donating Blood voluntarily and regularly is selfless act to strengthen communities and support health system. The need for blood is universal. In times of accidents and various types of surgical operation for medical treatment, blood is required for transfusion. Every year Blood Donor Day is observed on June 14 to raise awareness about the need to donate blood.

4. The Practice: - As a part of the practice, the NSS unit of the College organized awareness programme on voluntary Blood donation and Blood Science and Blood donation camp in collaboration with Barak Valley Voluntary Blood Donors Forum, Silchar.

5. Evidence of Success: - Voluntary Blood Donation Camp and awareness programme on Voluntary Blood Donation and Blood Science have been being organized since 2017. 29 and 39 numbers of students donated blood in the voluntary blood donation camp held at the college on 19-09-2018 and 29-03-2019 respectively. In 2020 and 2021, the practice could not be organized due to COVID-19 pandemic. The practice again resumed after the pandemic and voluntary blood donation campheld on 21st November, 2022. However, awareness programmes on Voluntary Blood Donation and Blood Science were organized without any intervention.

6. Problem encountered and Resource required: - Barriers to whole Blood Donation include having prior negative experiences with donation and donation related fear. Facilitators include altruism, having a personal connection to donation, donation centre incentives. Lack of awareness is also another factor that influences the process.

7.3 Institutional Distinctiveness

7.3.1

Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Response:

The college is located in Udharbond LA Constituency of Assam. Greater Udharbond area has Higher Secondary Schools, High Schools and many elementary schools. But one emptiness prevailed with regard to higher education in the area because there was no higher educational institute in the area till 1998.

Due to absence of higher educational institute in Udharbind area, students had to go to the district head quarter Silchar for receiving higher education. As the area is economically backward, it was not possible for most of the aspirants of higher education from remote areas like Kumba, Salganga etc. to go Silchar

for education. Dreams of higher education of many aspirants were not fulfilled due to the emptiness of higher educational institute in Udharbond area.

Realizing the emptiness of higher educational institute in greater Udharbond area, a few eminent educationists and social workers came forward as visionaries to establish a higher educational institute in the area. Hence, Jagannath Singh College was established on 19th April, 1998. The college is located in Dayapur Part II of Uadharbond. The aim of establishing the institute is to provide access to higher education for backward and deprived communities. This is one of the priorities and thrust areas of the institute.

Performance of the Institute in its Priority and Thrust Area of Access to Higher Education for Backward Communities in Udharbond Area:

The institute accommodates students from diverse socio-economic categories. Students from SC, ST and OBC are studying. The area is economically backward. Most of the students belong to the poor families. The proportion of female students is higher than the male students.

The above facts describe that a good number of students enroll in the UG Programmes offered by the college every year. On average, more than 40% students of the institution were from socio-economically backward communities during the last five years.

The founders of the institution were the visionaries to bring the backward class of greater Udharbond area to higher education. It is evident that the institution has been catering higher education to these backward communities.

Besides SC, ST and OBC Communities, the institution also accommodates large number of students from Adhivasi communities of tea garden areas of Udharbond like Mura, Murmu, Urang, Bhumij,Kalmadi, Kalindi, Karamudi etc. These adhivasi communities of tea garden areas are extremely poor and fall under SC category. Students from these extremely backward communities derive a platform in our college to gather knowledge and pursue higher education.

Jagannath Singh College is the sole degree college in Udahrbond area of Cachar district. The college is permanently affiliated to Assam University, Silchar. The main aim of the college is to fulfil the need for higher education in greater Udharbond area. The college has been successfully catering higher education in the area since its establishment.

Being an affiliated college, it follows the curriculum designed by the university. However, the college participates and helps in the process of curriculum framing through its representation in BUGS of Assam University, Silchar from the teachers as members.

TDC CBCS was introduced with effect from 2018-2019 academic sessions as per Assam University TDC Regulation 2018. The college implements CBCS curriculum through a well defined process. Prior to the beginning of every academic session, the IQAC prepares the academic calendar depending on the university academic calendar and the college prospectus. A general routine is prepared by the time table committee before the commencement of classes as per the CBCS Regulation. Unit wise courses are distributed departmentally. The courses are completed in time.

Internal assessments are conducted as per CBCS Regulation 2018. Special class tests are taken by the teachers. Remedial coaching is organized for slow learners.

The college creates a learning environment beyond the classroom by organizing co-curricular and extension activities which have high importance for holistic development of the students.

Majority of the students accommodated by the college are poor. Many passed out students from the college

have got placement in public and private sectors and many pursued higher studies.

The role of governance is immense in the successful journey of the college. The institute practices participative management in its functioning. There are different cells and committees which help the administration in the smooth execution of the policies formulated by the Governing Body.

The college gives importance on inclusiveness in education. It does not discriminate any student on grounds of language, sex, caste, creed and religion. It receives students from diverse socio-cultural backgrounds. The college inculcates constitutional responsibilities, values and rights through observation of national festivals and curricular activities.
